

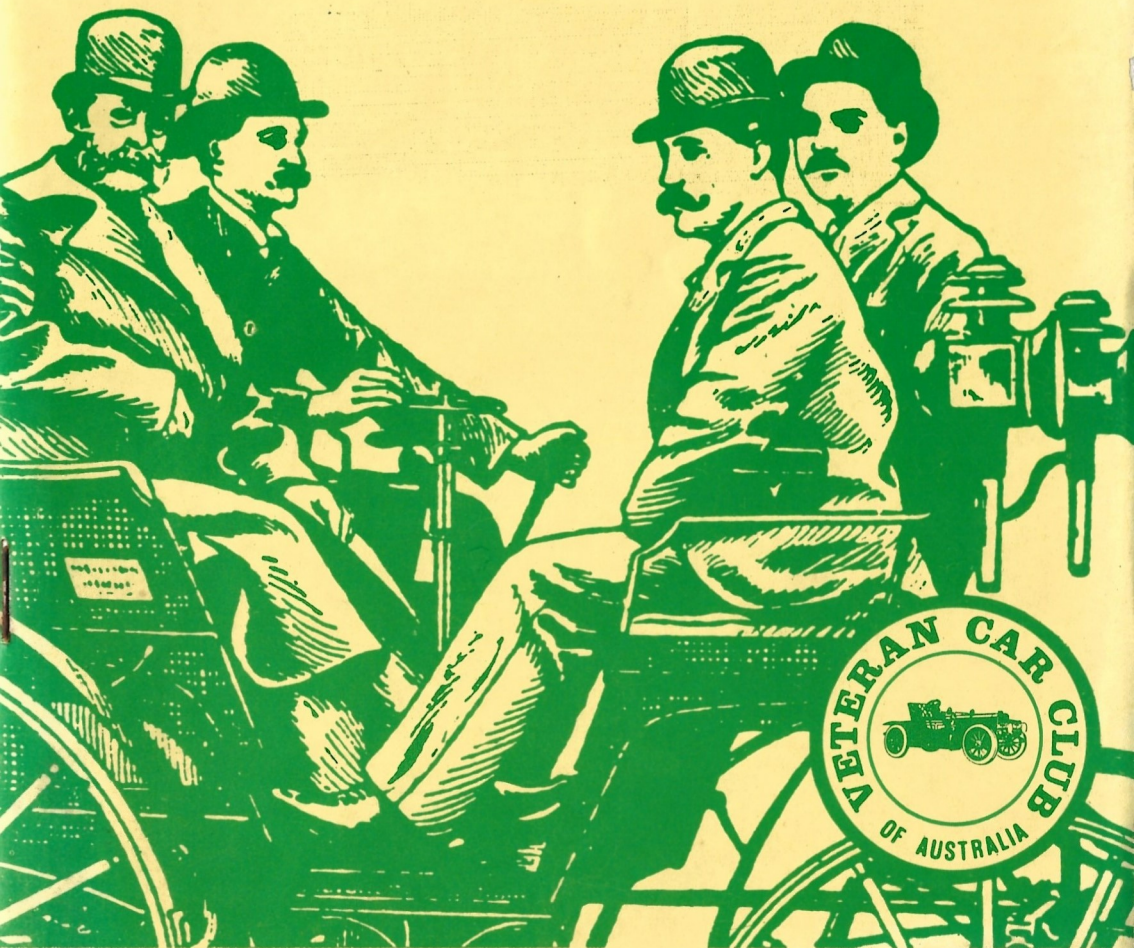

P.S. Investigation and Dating Report, with more information from George Roberts, will appear in August *SPIT AND POLISH*.

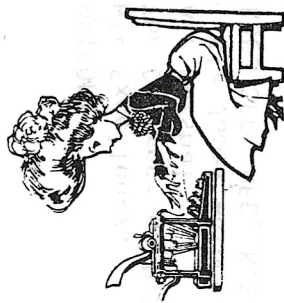

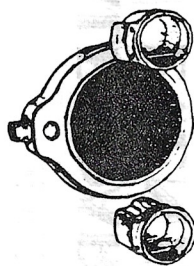

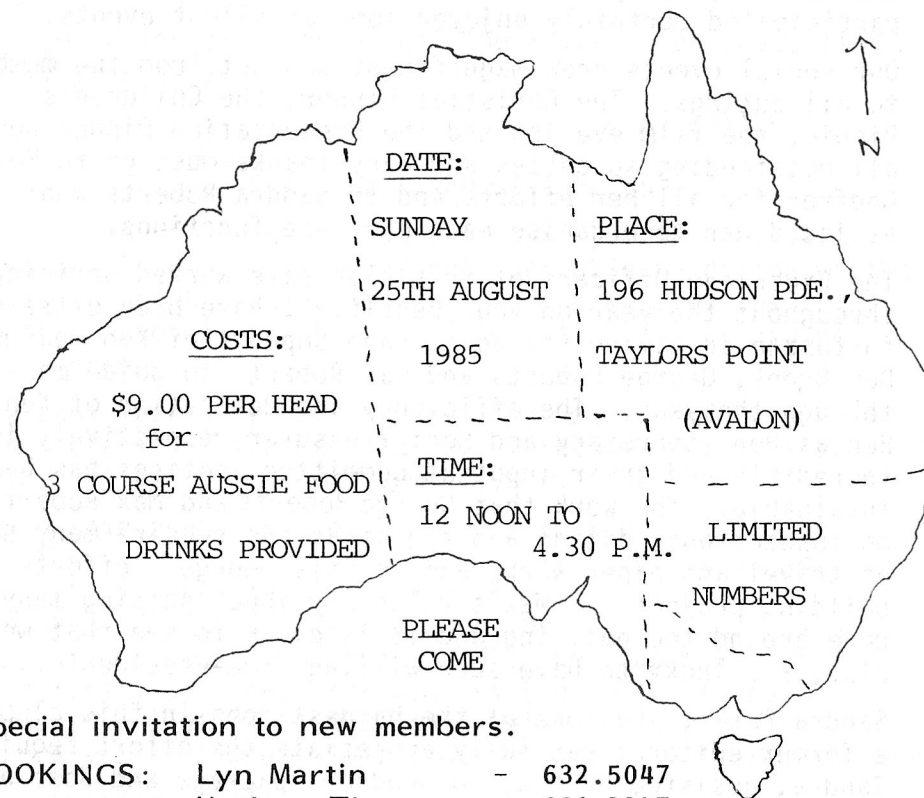

Sandra Roberts has one of the hardest jobs in this club. As a former editor I can fully appreciate the effort required by Sandra, assisted by Max, to produce, package and post an extremely interesting and informative SPIT AND POLISH on schedule each month. Again we must remember that Sandra was one of the mainstays of our Social Committee and her advice and assistance at management level throughout the year was invaluable.

The first year on committee for Ron Cox has been of great benefit to the club. His efforts in raising funds, printing and working on the building has been greatly appreciated.

I must single out Neil Johnston, our Honorary Builder, for special mention. Without Neil and his expertise, efforts and contacts, it would not have been possible to build our new clubrooms to the point where we are today. There are a lot of members who have helped him on the site and realise the contribution he is making, but there are only a few members on committee who are fully aware of the extent of his involvement in this building project. This club's

indebtedness to Neil for his efforts over the past several years is enormous and one deserving of the VCCA (NSW) highest honours.

In conclusion may I thank all the members for supporting me in my year as your President.

TREASURER'S REPORT 1984/85

It is with some regret that I present you with my last Treasurer's Report. I have not been able to decide whether it is the club that needs the break or me (perhaps both). On the whole, it has been an interesting and rewarding experience.

The past year's operations have been more comfortable, with the increase of fees to \$18.00. I recommend that they remain at \$18.00 for the coming year.

There have been many contributions to the Building Fund, which have enabled us to progress with the new building (now at lock-up stage). One more push is required to see it finished. By this I mean a push for funds and it is with this in mind that I propose: THAT the club makes an opportunity available for members (who wish) to pay a "Life Membership Fee" of \$1,000 (this being quite distinct from Honorary Life Membership). This opportunity to remain open for 12 months only.

With only 5% of the membership subscribing to Life Membership we will raise \$15,000 - enough to finish our building project. In support of this proposal, I have two \$1,000 cheques awaiting your approval. You will not only help us to finish our building project, but you will also get the promise that the club will never send you another reminder for dues.

Your club is in a strong financial position, our only major liability being \$13,200 in members' debentures, which is a tremendous effort indeed. Our surplus for the last twelve months is \$6,494.42, not as great as previous years and not as great as next year's (I hope).

Over the last 8 years as Treasurer, and for the many other jobs I stuck my neck out for, I have had to call on numerous

members for assistance of all kinds and I am grateful and proud for the response I have received. A very special thank you to Bill McCarthy for his untiring effort, looking after our property lettings.

An audited copy of our Balance Sheet, Income and Expenditure Statement will be published in SPIT AND POLISH.

In conclusion I hope you will support my Life-Membership proposal; I am sure the response will raise enough funds to see our Building Project finished.

Dear Sandy,

I am enclosing for SPIT AND POLISH a copy of part of a letter from Jim Sandy, one of our members who has taken the red and yellow Alphonso Hispano-Suiza over to America for the Hispano Suiza Rally in California.

"We have just completed 900 miles of touring in California and have hardly incurred any trouble at all. Indeed "we" (the car and I) were certainly NOT the slowest car, nor the most unreliable, our only trouble was a loss in performance over the last two days of the tour, wherein I could not fathom why the water did not boil, yet the oil got very hot and thin. Problem was solved on the afternoon of my return to Haywood, where I found the carburettor to be loose so that we were running too lean.

Being the oldest car in the tour, I guess we were a bit of an unknown quantity to the Yanks, who fielded H6B's and C's, some K6's and a trio J12's. The H6's were no problem and on one occasion I had a K6 pull over to let me through, but the best bit was passing John Perkins' J12 on the coast road (Route 1) going down to San Simeon. No way can the J12's hold the Alphonso on the twisting sections, but they get their own back on the straights.

In due course I'll have some pictures showing the Alphonso at about 500 ft in the Yosemite, quite probably the only Alphonso to have been there!"
